At the 1997 Biennial Convention this summer, Pi Beta Phi's Grand Council for the 1997-99 biennium was installed. As two new members begin their careers on Grand Council, two veteran Council members retired. Five members are continuing on Grand Council.

New to Grand Council are Grand Vice President of Membership Kay Knittle Brock and Grand Vice President of Philanthropies Lois Huston Ross.

Kay, a Colorado Alpha, graduated from the University of Colorado with a

bachelor's degree in physical therapy. Following graduation she worked as a physical therapist in a school for handicapped children. A member of the Kansas City, Missouri-Shawnee Mission, Kansas Alumnae Club, Kay has served as President, Arrowcraft Chairman, ACRIC and Theater Tour Chairman for the club. She is a former Sigma Alumnae Province President and Director of Membership.

An Indiana Delta, Lois graduated from Purdue University. She served her chapter as Vice President and Representative to House Corporation. Her alumna involvement includes serving as president of the Dayton Alumnae Club, chairman for Alumnae Advisory Committee and Iota Alumnae Province

Legacy honored at initiation

In a beautiful ceremony performed by Grand President Beth van Maanen Beatty on June 29, Ann Saterbak joined an organization to which both her mother and grandmother belong. She became a member of the Alabama Alpha Chapter of Pi Beta Phi. Both her mother, Celia Mills Saterbak, and grandmother, former Grand Council member Annette Mitchell Mills, are Alabama Alphas.

"The connection my grandmother and mother have with Pi Phi makes my initiation very special," Ann says. Because of her grandmother's involvement with the Fraternity, Ann grew up with Pi Beta Phi. "I remember always seeing angels and arrows in my grandmother's house," she says. "Those Pi Phi symbols added to my idealized view of her home."

A Texas native, Ann received her bachelor's degrees in chemical engineering and biochemistry at Rice University. She then completed her doctoral degree in chemical engineering at the University of Illinois at Urbana-Champaign. Ann currently lives in Houston, Texas, where she works as an Assistant Research Engineer at Shell Development Company's Environmental Division.

"Basically, I clean dirt," she says, explaining that she develops cost-effective methods of remedying oil and petroleum spills. In her spare time, which is limited because of her challenging career, Ann enjoys needlepoint, ultimate frisbee, aerobics and pottery making. "I leave work at work and tap into the other side of my brain on the weekends," she says.

Ann also loves traveling. She has visited 29 foreign countries, where she enjoys learning about each area's past. "Visiting cities with deep histories, such as Egypt, really puts you in your place in the context of history." Ann has much to offer Pi Beta Phi—outstanding academic achievements and numerous community activities.

At convention Grand Vice President of Membership Carol Inge Warren and Grand Vice President of Philanthropies Betty Blades Lofton said goodbye to Pi Beta Phi's Grand Council. She has been an Alumnae Club Rush Information Chairman, a Province Coordinator, a Collegiate Province President and Director of Membership, to name a few. For the past six years, Betty has been the Grand Vice President of Philanthropies. In that capacity, she shared the true meaning for giving—"love of humankind." Betty will continue to serve Pi Phi in her new position as President of the Pi Beta Phi Foundation. Her work will be remembered through the Betty Blades Lofton Scholarship Endowment to the Foundation.

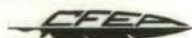

Ruth enrolled in the silk-painting class at Arrowmont this spring. "I am always amazed at the professional level of teaching at Arrowmont, yet in such a relaxed atmosphere that makes it feel like home," she says. Ruth plans to return this fall for a watercolor class.

Louisiana Alpha Susan Ivy has taken silk-painting at Arrowmont four times. Unable to paint at home because she lacks the necessary equipment,

New Work "Springs Up" in Arrowmont Sculpture Garden

Stone sculptor Ron Koehler has quite a history at Arrowmont. Professor of Art at Delta State University in Cleveland, Mississippi, Ron has taught at Arrowmont five times and was a member of the Arrowmont staff in 1982. In fact, Ron met his wife, Catherine, at Arrowmont, when she and her mother were enrolled in a screen-printing class.

So, it was quite fitting when Arrowmont Director Sandra Blain asked Ron to design and donate a sculpture for the Arrowmont Sculpture Garden. Ron's piece, "Spring Leap," joins two others in the garden, which is located next to Hughes Hall.

"Usually I dislike creating commissioned pieces, yet 'Spring Leap' was an enjoyable, easy piece to complete," Ron says. "Spring Leap" is a marbled fish in a complete circle, vertically mounted on an oval limestone base. The fish

mirrors one of Ron's trademarks—the circular theme. "I believe that, for me, circles symbolize cycles," he says. "Cycles of change, cycles of life, returning to the beginning and starting over."

Ron says that he enjoys all aspects of Arrowmont. He says that the school's equipment is far superior to other art schools he has visited. He enjoys being with students. "I enjoy seeing a beginner's pride in completing his or her work," he says. "I get many ideas from students and much satisfaction from teaching at Arrowmont, more than at the university level because I think the students here really want to learn."

Ron hopes to return to Arrowmont soon. He wants to take a wood-turning class in the new studio. From instructor, to staff member, to student, it seems that Ron Koehler has come full circle.

"If you can't read, you can't succeed," Texas Governor George Bush said. The **DALLAS, TEXAS ALUMNAE CLUB** increased the likelihood of success for all Texans by raising \$125,000 for literacy at its 13th annual Pi Phi Charity Style Show. The club donated \$50,000 to Literacy Instruction For Texas, an agency that promotes adult literacy. The agency will use the money to purchase new computers and interactive learning equipment. The Pi Beta Phi Reading Center at Trinity River Mission was funded with proceeds from the style show. This community center promotes after-school tutoring for Hispanic children. The charity style show was such a great success that the Dallas Alumnae Club was able to endow the Dallas Alumnae Club Scholarship in honor of Ann Dudgeon Phy, which will be administered by the Pi Beta Phi Foundation. During the style show, the Dallas Alumnae Club presented two area residents with the Unsung Angel Award. This award is given annually to Dallas citizens who have promoted literacy in the community. This year's award winners are Dallas Chief of Police Ben Click and retired school teacher Franne Jackson.

Members of **OHIO ALPHA** demonstrated their dedication to literacy at the chapter's Professor Tea. Members invited their favorite professors to the house for a luncheon and program about Pi Phi philanthropies. This year, each professor was asked to bring a children's book to the event. These books, along with the books donated by each chapter member, provided a foundation for a children's section at the local library.

Recording books on tape for the pediatric library at the community hospital is just one of the Links to Literacy

activities keeping the **ARLINGTON HEIGHTS, ILLINOIS ALUMNAE CLUB** busy. 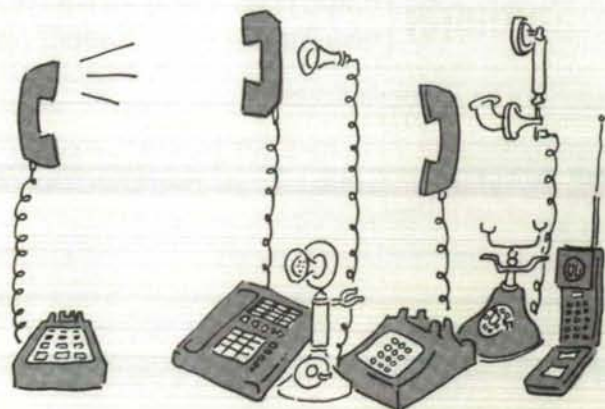

The Fraternity owes Adrienne a debt of gratitude for her many years of unselfish service to Pi Beta Phi.

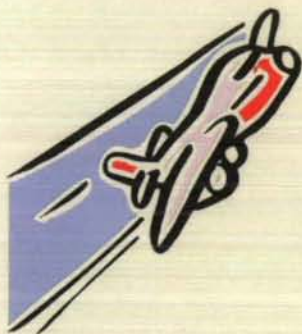

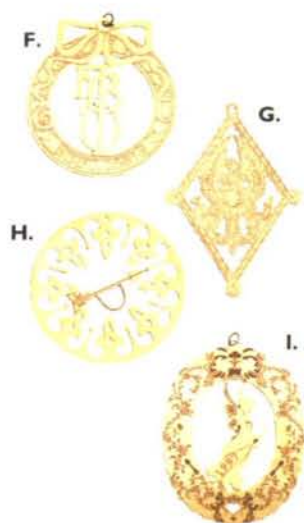

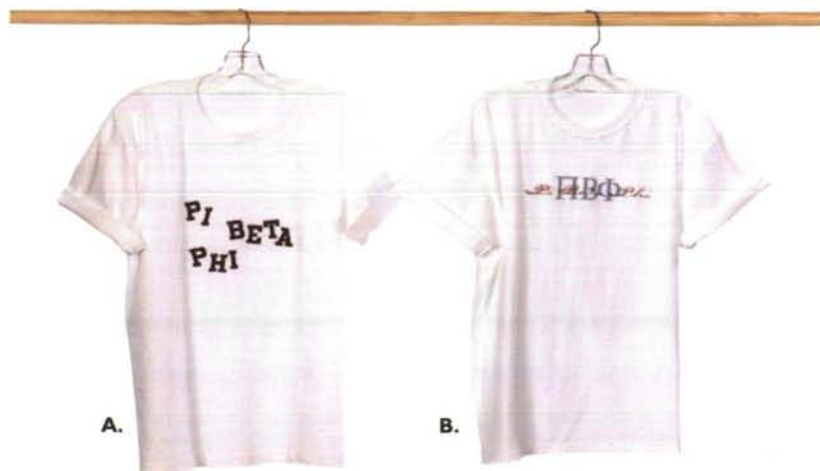
