Pi Beta Phi Constitution and Statutes, Article III, Section 8. *Term of Office*

International Officers shall assume their duties at the close of the convention at which they are elected. An officer shall serve a term of two years or until her successor is elected or appointed.

A. An officer may serve no more than three terms in any one position on Grand Council, nor a total of more than ten years on Grand Council.

B. A Director may serve no more than three consecutive terms in any one office, nor more than ten consecutive years as a Director.
